



Members, please note there are two nomination forms available on GJF website. These forms are:

COA Zonal Chairman Nomination Form
COA Panel Nomination Form

Note: Members can contest for both the elections i.e. Zonal Chairman and Panel Member.

- Members are requested to download the form and duly fill with all necessary details (all details are mandatory). Please select your zone / panel as per the GJF records given in the dropdown box in the column no. 5 in the Nomination Form.
 - Example 1. If a member is registered with GJF from southern region, he / she could contest as Zonal Chairman for SOUTH Zone only.
 - Example 2. If a member is registered with GJF as a large retailer, he / she can contest in the large retailer category only.
 - Such categories are available in the eligible voters list uploaded on www.gjf.in
- Members who wish to contest for the Election required to mandatorily fill the Affidavit available on <http://gjf.in/election.html> along with the COA nomination form.
- Affidavit is to be furnished on non-judicial stamp paper of Rs. 10 only.
- Affidavit is a declaration by the member that he/she is qualified to act as a Director of GJF and necessary documents which enables us to identify the panel / zone the contesting member belongs to.

Instructions to fill the GJF COA Nomination form

- Name of the candidate proposed to contest for the Elections 2016 and the same should be the authorized representative of the firm, registered with GJF.

- Passport size photograph of the candidate who wish to contest for the Elections to be affixed as per the instruction given in the form.
- Name of the company: Kindly fill the name of the company, where the candidate is the authorized representative and the same should be registered with GJF.
- Zone / Panel to be selected from the dropdown box, given in the form.
- Any contesting member is required to be proposed / seconded by atleast two GJF members. For the Zonal Chairman, the proposers needs to be from the same zone only. And for panel nominations, the proposers needs to be from the same panel only.
- Eligible members who wish to contest for the COA, has to submit the duly filled COA Nomination form available on website of GJF, along with duly filled Affidavit with all the necessary documents
- Contesting members are also required to pay enrolment fees of Rs. 5,000/- and a refundable deposit of Rs. 20,000/- (to be refunded on completion of GJF Elections 2016) in favour of “All India Gems and Jewellery Trade Federation” to be paid by way of Cheque/NEFT.
